## INVITATION INTERNATIONAL BOXING TOURNAMENT (GROUP A) DEDICATED TO THE MEMORY OF NIKOLAI MANGER

Ukrainian Boxing Federation cordially invites national boxing Federations to take part in the International boxing tournament (group A) dedicated to the memory of the honored coach of Ukraine Nikolai Manger.

The tournament will take place in Kherson, Ukraine during **April 15-21, 2019**.  
The arrival date – **April 15, 2019** the departure date – **April 21, 2019**.

The tournament will be held in accordance with AIBA Technical and Competition Rules in 10 weight categories. Bouts will consist of 3 rounds 3 minutes each with 1 minute break between the bouts. Electronic judging system will be used. Boxers born between the age 19-40 (2000-1979) may take part in the tournament. The boxers must have valid international AIBA record books, red and blue uniforms. The judges must have a valid international AIBA passport.

*Each team is obliged to bring 1 (one) AIBA 1,2- or 3-star judge.*

### Team Composition

National Federations can send maximum 10 boxers – one in each weight category.

1-5 boxers: 1 official, 1 judge.

6-10 boxers: 2 official, 1 judge.

### Financial Conditions

All participants are responsible for the travel expenses to and from the city of Kherson, Ukraine.

The organizers will provide accommodation and board for the judges.

Boxers and officials must pay for their accommodation and board

Single occupation 70 Euro per person per day

Double occupation 50 Euro per person per day

National delegations must obtain visas in the Ukrainian embassy in their country.

### Prizes

The boxers winning the 1-3 places will get medals, diplomas and valuable prizes.
